All other terms and conditions remain unchanged.

Q1.) Could you please clarify in **Section 3.2.2 Firm Experience: Selected Project** in the "Submission Requirements and Evaluation" section of the RFP document (page 78 of 93), in the first paragraph, it is mentioned that "(...) in the past five (5) years the proponent has participated in projects with a full scope of services as per RS1 and RS2" but in the list of Zone B projects, it is mentioned that "projects must be completed over the last three (3) years". Please let me know if we can include projects dating back 4 or 5 years or if they must have been completed within the past 3 years.

A1.) For Zone A (Correctional), the projects by the firm must be completed over the last five (5) years or are currently in the construction phase as of May 2018. For Zone B (non-correctional), the projects by the firm must be completed over the last three (3) years or are currently in the construction phase as of May 2018.

Q2.) Can you confirm if proponents who are selected for the Standing Offer list are precluded from being selected for other work that is released outside of the Standing Offer agreement?

A2.) Please refer to GC 13 of the General Conditions – Conflict of Interest and Values and Ethics Codes for the Public Service.

Q3.) Upon reviewing SRE1 on pages 76 – 79, it is specified that the submission be limited to 15 pages. The recommended pages counts for each section is:

4 (3.2.1) + 9 (3 project x 3 pages each for 3.2.2 1 , 3.2.2.2 & 3.2.2.3) + 2 (3.2.3) + max
4 (3.2.4) = 19 pages.

A3.) The maximum number of pages (including text and graphics) to be submitted for the Rated Requirements under SRE 3.2 is **nineteen (19) pages**.
