In order to ensure the accuracy of the subsequent summary, the WEBEX session will be recorded. By joining this session, you automatically consent to such recordings. If you do not consent to the recording, discuss your concerns with the meeting host prior to the start of the recording or do not join the session. Please note that any such recordings may be subject to discovery in the event of litigation.

2. One-on-One Supplier Consultations:

Canada intends to conduct individual sessions with interested suppliers to discuss any comments provided in their response to the RFI. If your organization is interested in taking part, please include a request in the response to the RFI and the PASS SA Authority will be in contact to make further arrangements and provide additional information on the parameters of the meeting.

PLEASE NOTE: As with your responses to the RFI, these individual consultations are not meant as promotional opportunities for suppliers; therefore, while some marketing information can be presented in order to provide background on your organization, it is requested that this be kept to a minimum.
