Amendment No. 005 is raised to answer:

QUESTION 1:

Further to the solicitation references of the supply of sterilizers and ultrasonic units. See page 17 item 1.2, Dental Equipment. In Annex E there is no mention/specification for this requirement.

Does this solicitation require the supply of sterilizers and ultrasonic units? If so please provide a mandatory technical specification.

All items in Annex E show a "Mandatory Technical Specification" as part of the requirement. Please see sample below.

Annex E has no "Mandatory Technical Specification" for both the sterilizers and ultrasonic units.

Would you please provide a "Mandatory Technical Specification" for both the sterilizers and ultrasonic units required as part of this solicitation?

RESPONSE 1:

Annex E and F includes sample items from each category for evaluation purposes.

Sterilizers and sonic washers are not sample items requiring product information.

The intent of the requirement is to establish a regional individual standing offer for the provision of dental equipment, instrument, handpieces and supplies (for use by the First Nations Inuit Health Branch of the Department of Indigenous Services for delivery locations in Manitoba.

Individual purchases of these items will be limited to a maximum call-up of \$25,000 including GST (see amendment 1 below).

QUESTION 2:

If there is a requirement for sterilizers and ultrasonic units I would respectfully ask for a two week extension to the closing date in order to secure delivery pricing etc. for the response.
