Amendment 006 to our Solicitation to answer questions from the industry.

Enquiries – Bid solicitation – Clause #2.3

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of enquiries.

Here are the questions we have received:

Question 16 : Would you be willing to use the BLM published index for helium price revision?

Answer 16 : As mentioned in Amendment 002, we will not add a clause to allow price adjustment.

Question 17 : In addition, it is mentioned in Section A.6.3.1 (page 27 of the document) that the two NRCC of Greater Montreal (Montreal and Boucherville) are included in this tender. Are all the departments and/or applicants of the NRC Boucherville site included in this tender?

Answer 17 : Yes. As mentioned in Amendment 002, this is a Master Standing Offer. Designated users (in section 6.4.3) include any government department, agency or Crown corporation listed in Schedules I, I.1, II, III, of the Financial Administration Act, R.S.C., 1985, c. F-11 of the Province of Quebec. Designated users in the Montreal, Quebec and Saguenay regions will be able to place orders. In Annex A.6 we have provided the addresses of the main users mentioned in Annex A.2.
