### **QUESTIONS AND RESPONSES**

#### **Question 1:**

Under 3.1.6: Stream 1 (Master Planning) Mandatory Experience, item 3 requires the Proponent to demonstrate experience in the capacity of Prime Consultant.

In the delivery of very large master plans for complex government clients, consultant team structures can also be very complex, involving a diverse range of designers, engineers and project management companies.

Our understanding of Canada's intent is to qualify a Proponent who has had the leading role in designing and delivering a Master Plan on behalf of an end user/client. This leading role would include authorship of the design itself, as well as coordinating control over a complex design team and the stakeholder process. If these aspects can be demonstrated in the project experience submitted under 3.1.6, will the Proponent pass the criterion, or is it mandatory that the contractual relationship was directly between the end user/client and the Proponent, without an intermediate agent such as a project management company.

#### **Response 1:**

For the purposes of this RFP, the Prime Consultant is defined by Canada as both the main contract holder and lead responsible for managing the project team/final deliverable(s).
