1. **Answer questions raised by the Industry;**

Question #001:

Are we allowed to send 30 lab samples if they are representative of what we can do on the line? (They would be all from the same code, as per the contract requirements)

Answer #001:

Bidders can send lab samples as long as it meets the technical specifications outlined in the Request for Proposal (RFP).

Question #002:

We were wondering why the 3 IMPs weren't just added on to the existing contract as an amendment?

Answer #002:

The IMPs on the existing contracts were evaluated and accepted through the RFP process. These items were approved and a budget was set based on these IMPs. The new items which are listed in W8486-19SP0A/A have to go through the same process as all other IMPs.

Question #003:

2 out of the 3 products won't meet the fat content requirement "Fat not to exceed 35% of total calories"(page 50).
By nature, smoke meat is not something "low fat". The products might not meet that clause and unfortunately the timeline allowed for the bid is too tight to try to reformulate these products (Pizza pasta, Smoke meat). What is the process?

Answer #003:

A modification has been made to the Request for Proposal (RFP) to address the fat content requirements. Please see section 2. of this solicitation amendment.
