This solicitation amendment is required to incorporate the questions and answers relating to the Request for Proposal.

1. This RFP Amendment 003 is raised to incorporate the questions and answers relating to the Request for Proposal.

The following questions and answers relating to the Request for Proposal are hereby incorporated into this solicitation amendment:

Item	English
Q1	<p>The Technical Evaluation matrix at Spec para 8.1.6 states that the LRF must have undergone testing for Rain.</p> <p>Given that MIL-STD-810G considers the Immersion test a more severe test for determining water penetration, would an LRF that has passed the MIL-STD-810G Immersion test for 60 minutes at 1m be considered compliant with the mandatory requirement?</p>
A1	Yes, an LRF that is compliant with the immersion testing in MIL-STD-810G would be considered compliant with the rain requirement.
Q2	<p>The Technical Evaluation matrix at Spec para 8.1.6 states that the LRF must have undergone testing for Icing.</p> <p>The MIL-STD-810G icing test involves accumulating a minimum of 6mm of ice on the item being tested. This supposes that the item will be employed in a static role while exposed to icing conditions for a significant period of time. Since the LRF being sought is a small hand-held, pocket-sized LRF, it is unlikely that a user will maintain hand-held observation with the device in icing conditions for sufficient time to accumulate 6mm of ice.</p> <p>Could the environmental requirements at paragraph 8.1.6 of Annex B to the solicitation be amended to remove the requirement for the LRF to have undergone MIL-STD 810G testing for icing?</p>
A2	Yes. This requirement is typically for a tripod mounted equipment and although there is a requirement to have the ability to interface with a tripod, this is not the normal configuration for this LRF and therefore the Icing requirement should not have been included. Consider the Icing requirement removed.
