QUESTIONS AND ANSWERS

Question 42:

Rated Criteria R.3.2.3 for the Programmer/Analyst (Java) requires “experience over and above the minimum 3 years required in the Mandatory Criteria M.2.2.3” with full points being awarded for 5+ years. Since M.2.2.3 requires experience within the past 5 years, please confirm that the 5-year window does not apply to R.3.2.3.

Answer 42:

Confirmed. The time constraint specified in the Mandatory Criteria M.2.2.3 (within the past 5 years), does not apply to the Rated Criteria R.3.2.3.

Question 43:

Rated Criteria R.3.3.4 for the Programmer/Analyst (UI) requires experience developing applications using React and Redux JavaScript libraries, with full points awarded for 4+ years of experience. Since the Redux JavaScript Library has only been in use for 3 years, will CBSA amend the requirement so that full points are awarded for 2+ years of experience?

Answer 43:

Bidders should refer to Solicitation amendment 003 and the response to questions 19 and 28.

Question 44:

For any Rated Criteria that requires experience over and above the corresponding Mandatory Criteria, please confirm that the experience can be outside of the time constraint (if any) required by the corresponding Mandatory Criteria.

Answer 44:

Confirmed.

Question 45:

Will CBSA kindly extend the closing date to allow vendors time to receive and review answers to questions that have been submitted?

Answer 45:

An extension has been granted. See Solicitation amendment 003.

Question 46:

With regard to Corporate Mandatory Criteria , M.1.1, specifically it being requested that “the description of the information technology services be limited to one page”; will the Crown please confirm that signed client reference letters (including the provided response table) may exceed 1 page in order to ensure that the requested details are sufficiently addressed?

Answer 46:

The description of the information technology services does not include the reference signed letters. The description of the services (summary of scope and key responsibilities) provided under each contract must be limited to one page to be attached to the Bidder's Response Table, if the box reserved for this item #1 is not enough to provide the brief description.

Question 47:

In regards to R.3.3.3 in Solicitation Amendment 003, the scoring changed to the following:

2+ to 3 years = 4 points

3+ years = 4 points

The maximum points for this requirement is 6 points. Can the Crown please confirm that the scoring should read as follows:

2+ to 3 years = 4 points

3+ years = 6 points

Answer 47:

That is correct. See amendment below.

Question 48:

For M.1.2, are companies able to use 3 contracts for each resource category to show that the resource has been working for the company for a minimum period of 6 months, or do companies have to demonstrate all resource categories across a total of 3 contracts?

Answer 48:

Bidders must demonstrate their experience and capability to supply all the resource categories in M.1.2 across a total of 3 contracts.
