The following changes in the bid documents are effective immediately.
This addendum will form part of the contract documents.

General Comments

1 This Addendum addresses 5 bidders' questions received on September 24th, 2018.

Q1. Section 31 23 33 Item 1.4.1 In addition to stockpiling the excavation tailings on site, can we also dispose of the Hydrovac tailings on site.

A1. Hydrovac tailings can be disposed of on-site with the provision that the tailings get leveled out with the landscape before the project is completed.

Q2. Will water be available on site for watering sod, for hydrovac and/or for other operations.

A2. Water will be available [for] watering sod, for hydrovac and/or for other operations.

Q3. Section 03 10 00 Item 2.1.1.1 The duct spacers are cold Spec'ed as "Underground Devices". Are commonly used duct spacers from other manufacturers acceptable alternates.

A3. It is expected that duct spacers from other manufacturers are acceptable provided they meet the functional needs. Alternate duct spacers are subject to review and approval through shop drawing submittals to Departmental Representative.

Q4. Section 26 05 31 Item 2.1.2 and 2.1.3 Are the NEMA 3R junction boxes to have screw covers or are they to be a hinged door type.

A4. Both screw covers and hinged-door NEMA 3R junction boxes are acceptable.

Q5. Section 33 65 73 Item 3.2.3 and Drawing E108 The drawing does not indicate a mud slab, will this be required.

A5. Mud slabs are not required but may be used at the discretion of the Contractor.
