Questions and Answers

Q1. Is this a new RFP for the Vernon area or a re-tendering?

A1. This a new RFP for Vernon weather observations services

Q2. In additions to the standard flights, are there any supplementary programs planned within this RFP?

A2 No supplementary programs at this time.

Q3. Is observer training planned for Stony Plain, AB or will it be done at site in Vernon?

A3 MSC BC provides three days of initial training to contractor and contract resources on site in Vernon.

The Contractor is still responsible for the expenses related recruitment of staff, getting staff to the initial training and also for any annual or additional training (outside the initial training) required for himself or staff.

Q4. Is Vernon designated helium or hydrogen for lifting gas?

A4. Helium is the lifting gas at this location as per 1.1.2 in the RFP.

Q5. On page 9, Section II (Financial Bid), sub-paragraph 1.1, it is stated that " The total amount of Applicable Taxes must be shown separately. All information relating to price must appear only in the financial bid. No price may be indicated in any other section of the bid."

On sub-paragraph 1.2. of the same page and section, it is stated that Bidders should include (a) their legal name and (b) the name of the contact person (including this person's mailing address, phone and facsimile numbersetc.

Based on my understanding that the information mentioned above is to be shown only on the Financial Bid Sheet (Annex B), I do not see how it can be done, due to the obvious reason that there is no space to write it on. How and where else can we present the information?

A5. The Bidder may include the requested information anywhere within his financial bid either before or after the tables.

All other conditions remain the same.
