

ADDENDUM #4 / ADDENDA NO 4

Further to the above- mentioned Request for Proposal documentation previously forwarded to your firm, Addendum (#4) is hereby issued.

BIDDER QUESTIONS:

- Q1 [There are] concerns regarding the Mandatory Requirements, specifically M4 with the way the requirement have been laid out. M4 states [Certified Technicians] must have:
 - (a) WSBC insurance in good standing However, no individual is able to obtain this. The company as a whole is WSBC insured. Can you please clarify?
 - (b) Read Seal Pipefitter/Steamfitter This is a separate trade from plumbing and may have dual ticketed employees but this should not be required as there is no steam at the site and plumbers are qualified to do pipefitting. Is this requirement necessary?
 - A1 (a) That is correct. The WSBC requirement should apply to the business as whole and not individual employees. A new mandatory criterion will be added to reflect the need that the Bidder must be WSBC insured in good standing. See the revised Mandatory Technical Criteria below.
 - (b) There are steam boilers on the site and we would need someone who understands boiler code and can install or work on steam boilers. To allow flexibility, the mandatory requirement for all Resources identified as Certified Technicians to have a Steamfitter/Pipefitter certification will be removed. Then, a new mandatory criterion will be added saying that at least one (1) Certified Technician on the Proposed Project Team must have a Red Seal Certification in Steamfitting / Pipefitting. See the revised Mandatory Technical Criteria below.
- Q2 [There are] concerns that R1 is unachievable. To have a tradesperson who has three tickets would be very difficult to come across. Can this be relaxed?
 - A2 The intent of R1 is to award points to Bidders with Lead Technicians who have additional certifications than those indicated in M4. However, acknowledging the difficulty for one person to have multiple tickets, we will be changing R1 to allow any Certified Technician on the Proposed Project Team to have the certifications. See the revised R1 below.


