## AMENDMENT 003

This amendment is raised to respond to questions received to date on October 5, 2018.

### Questions:

**Q7.** I work with a Canadian manufacturer who does not have yet their ANSI/BIFMA e3-2014 certification. Can you accept their product?

**A7.** ANSI/BIFMA e3-2014 certification is required.

**Q8.** On the pdf and autocad floorplan, room 1-233, there is no # on workstations; please clarify

**A8.** In room 1-233, we see only one workstation (item #1), 4 items #28 and 3 items #27. The NFB will move 3 existing workstations which are not shown on the plan since they are not part of this RFP. Workstations to be moved are equivalent to item #3.

**Q9.** Item #28 does this item only serve as a divisor? Can we put a laminated divider (without drilling the surface)

**A9.** No, it is not only a divisor. The module is also use for accessory mounting.

**Q10.** Item # 14 - Please specify the electrical module; only electrical outlets? How many? The connection is made in a ground module with a plug or " hardwire "

**A10.** The module requires 2 electrical outlets and a network jack. The connection is made in an electrical outlet on the wall adjacent to the table.

**Q11.** Items 15 to 21 - Monolithic panels; to confirm that you want laminate inside and outside? We recommend acoustic fabric inside (for better acoustics)

**A11.** We confirm that monolithic panels must be covered with laminate tiles on both sides.

**Q12.** Items 18 to 20 - Electrification 2 triplexes (6 outlets) at the base; very few manufacturers offer triplexes; we offer duplexes, and we recommend a maximum of 8 electrical outlets per set (including item # 34) to avoid overloading the system. The normal load of a workstation contains: 1 PC (or Laptop), 2 screens, 1 lamp ... and with the demand in USB port, no more charger for phone; which leaves 3 out of 8 (or 5 out of 10) unused outlets. Please confirm if your needs are more intense, because possibly you should go to a 6-circuit system (10 wires) to support the load ...!

**A12.** Three duplex sockets are accepted instead of two triplex sockets. Most of the workstations have height adjustable surface, 1 computer, 2 screens and a lamp. Some users have additional needs, example of which are:

- Some users have a third screen and-or a second computer or a graphic tablet.
- The members of the Helpdesk team also have an electrical module to check the equipment of users.

The checks were made to ensure that we have the right electrical circuits.

**Q13.** Item # 5 & # 6 36 "deep adjustable work surface with +/- 2" tolerance - Would you accept 33 "deep?

**A13.** 36-inch deep work surfaces are used for technical and artistic work, the ergonomics of which require a depth of 36 inches with a 2-inch leeway. A surface of 33 inches will not meet the needs.

**Q14.** ANNEX A-1 ENVIRONMENTAL CRITERIA - Leed " GOLD "

You are aiming for a level of "OR" certification, however, you are asking for work surfaces with PVC edges. For environmental reasons, our manufacturer has discontinued this application for ABS (which is a product + green) is it acceptable?

**A14.** There are no specific LEED requirements related to the use of PVC or ABS for edges. The supplier can therefore use what he wants, as long as the furniture has the environmental certifications required in the specifications and meets the maximum VOC emissions.

**Q15.** For pricing, all items are listed by floor for the price. However, your list does not include several components required to deliver a complete project. Please clarify how we should proceed.

**A15.** As per article 1.3 of Annex A, the supplier is responsible for supplying all hardware, edge or trim, connectors, brackets, components (including electrical components) and wall mounts, etc. to allow the complete, functional and safe installation of furniture.

In order to facilitate price submission a 'hardware' line has been added to the Basis of Payment for all these items not listed. See change of the Basis of Payment at the end of this document.

**Q16.** Are the tops for items 29, 30, 32, 33 and as a consequence item 31 the countertop in high pressure laminate?

**A16.** Yes, the top for items 29, 30, 31, 32, 33 must be in laminate as described in the tender documents.

**Q17.** 9.4 requests that the credenza cushion must have a stitching detail along all edges. Can the alternate stitching detail of none be considered?

**A17.** Yes, we are willing to accept no stitching detail as long as the thickness of the cushion respects the dimensions specified in the tender documents.
