Q78 We seem to have some confusion around the timing of events after the close of the RFP and would ask that you verify the sequence. Please see below our understanding (and related questions) based on the information in the RFP and various Amendments.

- a) There appears to be a 2 week gap between the end of Phase 1 and the start of Phase 2. Is this correct?
- b) The Phase 2 – Technical Solution Evaluation involves completing section 4.4.1 and 4.4.2 if a bidder has been selected to participate in this phase. When would these responses need to be submitted?
- c) In Part 1, Annex A, Statement of Work references the need to provide access to the solution (also see P.18 TS-1) and our understanding is that access to the solution would need to be provided once the 2 month period of Phase 2 is completed and hence once all or part of the GIS solution has been developed according to the requirements in 4.4.1 and 4.4.2. Is this correct?
- d) The Phase 3 – Technical Solution Demonstration involves providing a demonstration of the proposed product within 4 weeks from the completion of Phase 2. Amendment 4, A. 12 states the demonstration will happen in mid January which is approximately 6-7 weeks from the end of Phase 2. Please confirm the anticipated schedule.

A78: For clarity, all timing is estimated only. There are no absolutes or guarantees.

- a) Between 2 and 4 weeks.
- b) Two months following the contract award date.
- c) Correct. The evaluation process referred to in Amendment 007 is the evaluation of the work undertaken under the contract. Thus, at the completion of Phase 2 (date to be determined) Canada will request access to the modified solution to perform the Phase 2 evaluation. Bidders will be requested to participate in a webex evaluation of their solution.
- d) Mid February is the estimated timeframe for the exercise of option period 1.
