This amendment has been raised to answer the following question:

QUESTION:

I've been asked to look at the Agri-Food Canada Greenhouse LED Retrofit, it looks to be specified with a fixture from Lumigrow, is there an opportunity for approved alternate fixtures and control system to be bid or is it a closed specification?

ANSWER:

The Lumigrow fixture has been used as part of a pilot study at the greenhouse as described in Section 26 50 00, clause 2.5. However, the specifications are not intended to limit supply of new fixtures to any one particular manufacturer, providing that products proposed meet the project requirements, as indicated by the contract documents. '
