For the PTZ cameras are 120 Volt AC outlets planned and installed in the ceiling nearby them?

ANSWER 17:

The use of power injector is recommended for PTZ. The choice for the power injector position (that use AC power supply), must be done in collaboration with the Airport authority.

It is the CBSA's responsibility to provide these supplies through Jean-Lesage Airport.

QUESTION 28

In point 2.2.1 of the rated evaluation criteria, it is requested that our project manager has at least one professional certification (PMP, PMI, MBA, engineering degree or bachelor's degree).

If not, we can only obtain a maximum of 4 points and a minimum of 6 points is required. So without professional certification, our submission would be NON-compliant and rejected. Is it correct?
