Janitorial Services

This amendment was raised to answer site visit questions and to update the Request For Proposal.

1. PART 6 - SECURITY, FINANCIAL AND OTHER REQUIREMENTS

6.1 Security Requirements

1. At the date of bid closing, the following conditions must be met:

- (a) the Bidder must hold a valid organization security clearance as indicated in Part 7 - Resulting Contract Clauses;
- (b) the Bidder's proposed individuals requiring access to classified or protected information, assets or sensitive work sites must meet the security requirements as indicated in Part 7 - Resulting Contract Clauses;
- (c) the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites;

My question is this ... on 14 November, which is the bid closing date, what specific positions do you need with security clearances at either the Reliability Status and/or Secret level. I am not sure how we are to determine this during a site visit on 17 Oct and then secure clearances for all of the following people in the interim one month:

2. What are the bonding requirements at CFB Petawawa?

Previously for our client at CFB Suffield we have provided bid bonds with the bid. I cannot see anything in the RFP package stating that. Please let me know if performance, labour and material bonds are required.

3. Please confirm that 1 FTE is considered one person working 8 hours per day, not including a ½ hour lunch break.
4. As you are requesting electronic time and attendance systems, we would like to know if we would be allowed to install scanners in up to five locations around the base. One example might be the guard post at the entrance to the helicopter area of the base.
5. Can you please provide a PDF site plan showing all buildings in the RFP? Also, please indicate which buildings being cleaned DO NOT have water and the location of waste disposal containers across the base.
6. Please advise if we would be allowed to use non road-licensed vehicles, e.g. golf carts, Kubota transports, etc., on the base.

Answers:

1. The following list includes the present personnel that have "SECRET" clearance:

Site Superintendent x1
Site Operational Manager x1
Supervisors x6
Administrative Support Personnel x1
Janitorial Personnel x54
Operational Support Personnel x2

To answer the question from below, the individuals do not require security clearances on the date of award; they will have until 1 May 2019 to have their personnel cleared.

2. There is no bid bond. It is a Contract Financial Security which can be found on pg 31
3. See Annex A, SOW Para 6 b) 6); (An FTE is based on, on-site productive hours; not persons). Lunch breaks are not included in the FTE calculations.

Examples: One person may work 8 hours in one day = 1 FTE;
Two persons may work 4 hours each in one day = 1 FTE; and
Three persons may work 4 hours each in one day = 1.5 FTE

4. Installation of scanners at multiple locations throughout the garrison must be investigated and approved/denied on an individual basis due to security reasons. Therefore this question may not be answered at this time.
- 5 (a). PDF plans for the Garrison and Mattawa Plains attached. For reference only; all buildings may not be demonstrated.
- 5 (b). There is presently in excess of 274 waste collection locations throughout the Garrison to service all facilities. A map will not be provided.
- 5(c). There are limited locations (less than 10) that do not have water. These facilities are usually single ATCO type trailers.
6. Use of non-licensed or other transport type vehicles is NOT permitted on the Garrison or in any building or facility under this contract.

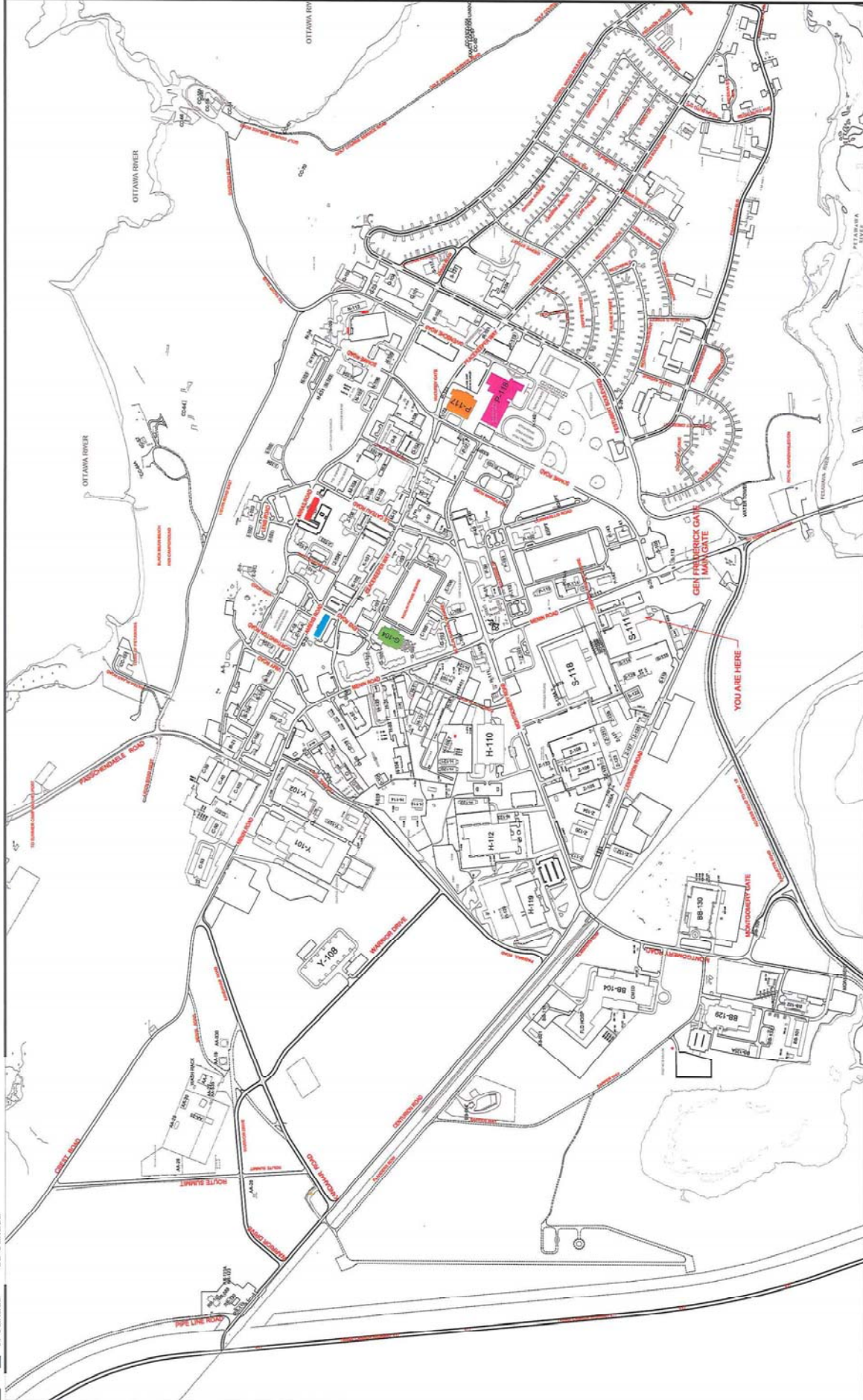

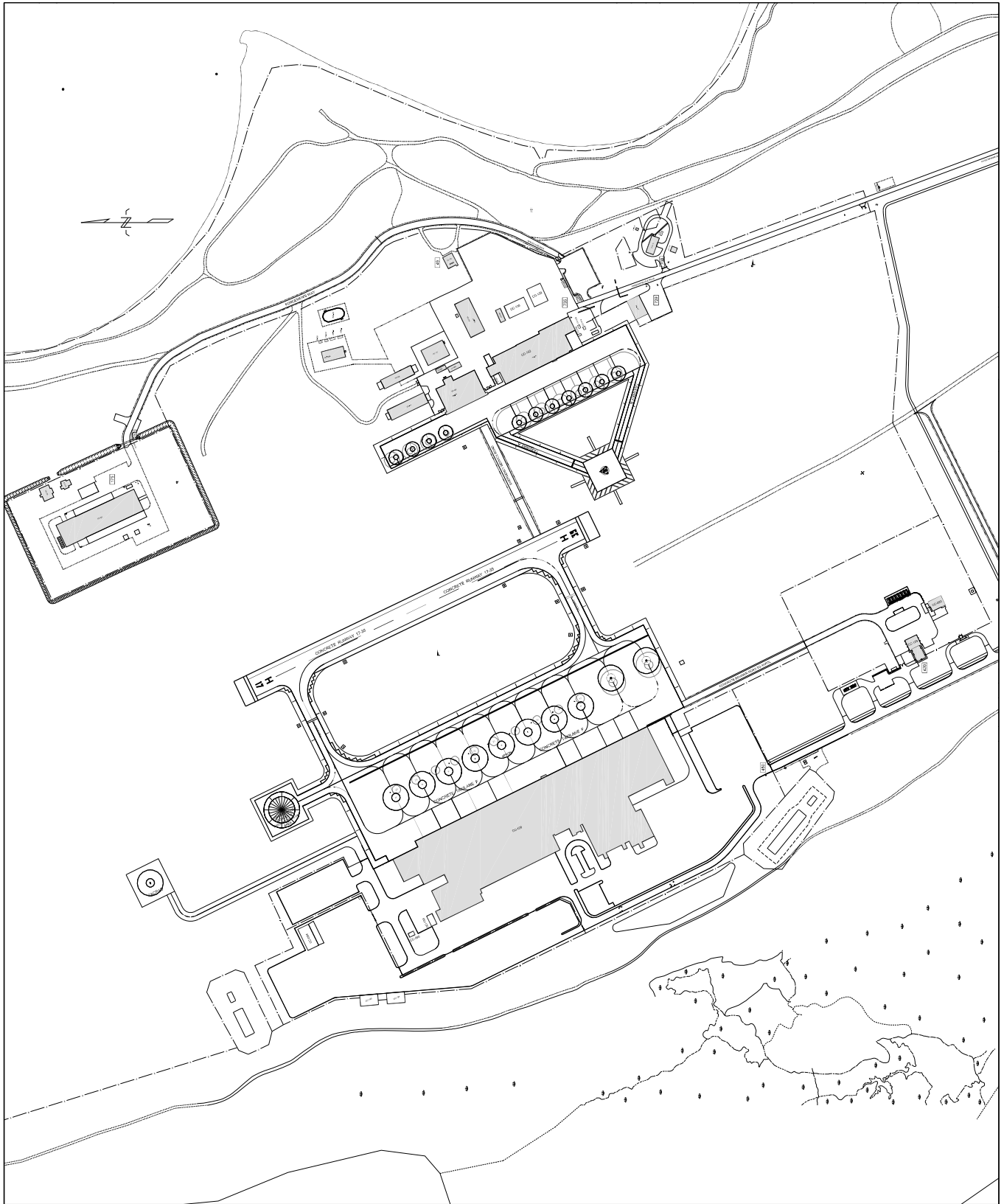
