AMENDMENT 1 TO SOLICITATION NUMBER W6369-19-A029/A IS RAISED TO:

1. Provide clarification and answers to questions from potential suppliers.
2. Extend the solicitation closing date by one (1) week from 24 October 2018 to 31 October 2018.

QUESTIONS AND ANSWERS;

Question 1	Is it possible to ship the entire 175 units by February / March 2019 with 24 months shelf life or would you consider having the shorter shelf life vials?
Answer 1	No, we will not accept delivery in February/March 2019. We will accept the first batch of 175 units to be delivered by 31 December 2018 with a shelf life of less than 24 months.

Question 2	Could you also share a date for placement of two additional orders of 175 vials each?
Answer 2	The second order should be early FY 19/20 but cannot provide an estimated date for the third order.
