➤ **QUESTIONS AND ANSWERS**

QUESTION 1

Are the requested services for the above referenced solicitation currently being provided or have they been provided previously? If so, please identify the means by which such services have been supplied (e.g., direct and or term employees, personal services contract, or contracted services through a company). If the services were contracted through a company, please provide the name of the contractor and the duration and dollar amount of the contract(s).

ANSWER 1

There was no previous contract for these services.

QUESTION 2

We note in the request for proposals (section 7.3) that it would be necessary to hold a valid Facility Security Clearance (FSC) at the level of NATO SECRET. We also note that in Annex A – Statement of Work, subsection 12 – Location of work, it is stated that “the work must be carried out on the DRDC Valcartier site.” In order to evaluate the costs associated with employees located outside the Quebec/Valcartier region to work on site at DRDC Valcartier, we would like to understand the amount of work (estimated) that must be completed at DRDC Valcartier and, if applicable, the amount of work that could be done on our premises.

ANSWER 2

There is a misunderstanding of security clauses # 1 which indicates that the contractor must hold a NATO SECRET level security clearance. It is not that the premises that must be NATO SECRET but the level of organization security rating required.

Security clause # 9 Reminder: The contractor /offeror MUST NOT remove any CLASSIFIED information from the identified work site(s) and the contractor/offeror must ensure that its personnel are aware of and comply with this restriction.

As mentioned in subsection 12 of the Statement of Work, the work must be performed on DRDC Valcartier site. Only occasional management tasks may be performed off-site by the project manager.

QUESTION 3

Referring to criterion "*CC2.3 - Physical category - Experience in Relevant Areas of Expertise*," its wording makes it clear that if we propose for example 3 resources and none of them has experience "with laser systems for 3 points " nor experience "surrounding the atmospheric propagation of light and lasers for 3 points ," but that each of these same 3 resources has the minimum experience in each of the other 4 " expertise field for 2 points each ," thus allowing each of these resources to obtain an individual score of $4 \times 2 = 8$, the addition of their marks will give a total value of $8 + 8 + 8 = 24$, but that , exceeding the maximum value fixed, will be reduced to 14. Does our reading of this criterion correspond to the intention of its author?

RÉPONSE 3

Yes, that is correct.
