PART 1 - GENERAL INFORMATION

1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), the Canada-European Union Comprehensive Economic and Trade Agreement (CETA), and the Canadian Free Trade Agreement (CFTA).

1.4 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

This email is to initiate an ePost Connect conversation, as detailed in the Standard Instructions.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 (ten) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in _____.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Bidders must provide their bid in a single transmission. The epost Connect service has the capacity to receive multiple documents, up to 1GB per individual attachment.

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

ANNEX “A” REQUIREMENT

Background:

The Department of National Defence requires the supply and delivery of one “Trailer Mounted Vacuum Excavation System” and all associated equipment to CFB Borden. This will be used to provide clean up productivity on any mid-sized potholing, soft excavation or cleanup tasks which includes jobsite debris cleanup of all types of spills.

1.0 Mandatory Technical Requirements:

2.1 The Trailer Mounted Vacuum Excavation System must have the following:

- 2.1.1 Trailer must have the ability to be pulled by a 4x 4 dually or equivalent and comes with towing pin – ie: 4500 Dodge Ram;
- 2.1.2 Trailer must come with electric brakes sized to accommodate on board equipment;

- 2.1.4 Must have a range of Fifty to Fifty-Five Horse Power system comes with battery start;

- 2.1.6 Hydraulic door and dump;

- 2.1.8 Four to Five inch hose;
- 2.1.9 Tool Rack;
- 2.1.10 Four to Five inch suction tools;
- 2.1.11 Two each – Four to Five inch suction hoses – minimum Twenty-Five feet in length;
- 2.1.12 Two Hundred to Two Hundred and Fifty gallon heated water tank to allow for winter operation;
- 2.1.13 Minimum 3,000psi water pump comes with auto de-clutch system;
- 2.1.14 One Half inch water hose reel comes with 6’ wand – minimum 50’ in length; and
