Responses to Questions from Bidders

Q1. We would like to request if Hemmera: Environmental Consultant can be included as part of the contractors bidding team? One individual from Hemmera was part of the design team with Anchor QEA, however, this individual will not be part of the bidders team for this project.

R1. This will be acceptable provided the individual will not have any involvement with the bidders team. Such involvement includes any review, advice, consultation, or comments on the Request for Proposal documents and the bidder's response to same and any other participation by the individual in this solicitation process.

Q2. We understand that our preferred bathymetric sub-contractor may have previously completed a pre-bid survey of the area. Could you please confirm that MCCOI Marine Ltd has no conflict of interest in regards to this project and may be included in our proposal as our designated Hydrographic Marine Surveyor (Bathymetric Surveys)? MCCOI Marine has participated on several remediation projects with our team, working as a third party surveyor.

R2. This scenario is not considered to be a conflict of interest or an unfair advantage. The successful bidder would still be required to conduct a pre-construction Bathymetric survey. PSPC will also verify the findings through an independent third party.

With regard to the above questions, should additional information that may create a real or perceived Conflict of Interest/unfair advantage be discovered, Bidders must re-evaluate the situation in the context of the relevant terms and conditions of the solicitation and carefully consider whether it would render a sub-contractor ineligible to participate in the bid.
