Questions and Answers

Question 54

“Producer/Director” is indicated. However, these are two very different positions, and the producer’s job seems to already be covered in lines 1 and 2 (project manager and production coordinator).

Does the client want a director who would also act as a director or, rather, an average rate for individuals who would fulfill each of these two roles?

Question 55

Digital audio recording and mixing. Does the client want a rate for a technician only or for a suite and a technician?

Answer 55

Question 56

Under blended hourly rate, a teleprompter is mentioned. Because this is an average hourly rate, we assume that the rate is only for the technician and that this excludes equipment as it would skew the average cost versus the duties without equipment. Is this correct?

Same question but for “Set Staging / Stage Decoration / Accessory Production.” This is the hourly rate for the technician only and not for the production cost of these elements. Is this correct?
