- .1 **Revise** Item 1.5.1.1 to read "...pressure testing, flushing, chlorinating, *protection and repair of damage to existing infrastructure including gates and roadway structure to pre-existing conditions* and other work incidental to..."

- .2 **Add** Item 1.5.16 as follows:

Wastewater Utility Storage Tank, Section 33 36 00

Description: Fibreglass sewage holding tank type B10000S or approved equivalent, including excavation, disposal of waste excavation at Upper Compound; supply, install and compact granular material, frame and cover; connection to sanitary system; backfilling, associated clean-up and items incidental to complete the work.

Measurement: Per unit installed.

- .1 **Delete** Paragraph 1.2 – Measurement Procedures.

- .3 SECTION 03 30 00 – CAST-IN-PLACE CONCRETE

- .1 **Add** Item 2.2.10 – Cold concreting:

.1 Do not place concrete on frozen ground.

.2 Maintain heating and hoarding for curing concrete in accordance with CSA A23.1-14/A23.2-14 for cold concreting.

.3 Include cost of heating and hoarding in bid price.

- .4 SECTION 31 23 33 – EXCAVATING, TRENCHING AND BACKFILLING – BUILDING FOUNDATIONS

- .1 Paragraph 3.2 Excavating (Foundation Footings):

.1 Item 3.2.9 – **Revise** to read "Dispose of surplus and unsuitable material *by stockpiling in the Upper Compound.*"
