Questions have been received from potential tenderers about the Request for Proposals. This solicitation amendment 001 is raised to summarize the questions and provide the answers to all potential bidders.

### Question #1:

Part 3 – Section 3.1: Please reconfirm if a bidder can only bid on one training course as per the terms and conditions.

### Answer #1:

Canada confirms that a bidder can only bid on one (1) training course and can also bid on up to all 6 training courses.

Part 3 – Section 3.1 clearly indicates "The\_Bidder can bid on more than one training course(s) specified in the Statement of Work, in Annex A but should submit one separate bid for each specified training course(s)".

### Question # 2:

Attachment 1 to Part 4, Training Course 1 - Working at Heights, RT1 – "Each proposed instructor should have successfully participated to at least 1 facilitation / animation program." We are seeking clarification to the definition and examples of a "facilitation / animation program".

### Answer #2:

Facilitation / Animation program: Plan, guide and manage a group event to ensure that the program's learning objectives are met effectively, with good participation from participants and full buy-in from everyone.
