Question 081:

Please confirm how many references are needed. If a company puts a list of five projects forward, does the company only have to include one reference for one of the five projects instead of a reference for each of the 5 projects?

Only one (1) reference is required per response.

Question 082:

Our organization is working on pulling together our response to the AI ITQ (Reference: EN578-180001). We are requesting an extension of at least a week to provide sufficient descriptions of our references.

Answer 082:

Question 83:

There was a large amendment for this ITQ released on Friday October 26, 2018. In order to give time for venders to review the amendment and to process through internal governance we are requesting a 1 week extension?

Question 84:

Amendment 009 was issued on October 26, 2018 to provide updated Terms and Conditions. Is the expectation a supplier has to agree to all these changes? Can we have a 1 week extension in order to comprehend and ensure that we can agree to these changes?

Answer 084:

By submitting a bid response to qualify for the source list, suppliers are agreeing to the terms and conditions. Suppliers will have the option to bid on subsequent requirements.

Question 085:

The changes made to Annex 3 on October 26th are significant and have legal impacts. Will the contracts be the same for professional services, cloud services and licenses? There does not seem to be any reference to the SACC clauses.

Can suppliers add their own terms and conditions that Canada would revise without being disqualified?

Answer 085:

The resulting contract will have a decision tree to apply the appropriate clauses depending on whether Canada is procuring goods, services, cloud services, or a combination thereof.

The SACC clauses do not appear in their usual format, however, a simplified format has been used to reflect their essence.

All other terms and conditions remain the same.
