Amendment:

A) Questions and Answers

Q1: With respect to Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.1 – *Boat*:
We would like to know if a boat with 6.8 m (22.3 ft.) length series aluminum and a width of 2.6 m (8 '2 ' ') would be acceptable.

A1: Yes, as long as the dimensions of the boat meet the minimum dimensions indicated on the request for proposals (Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.1 – *Boat*).

Q2: With respect to Annex "A" - *Requirement*, Section 2.2 - *Delivery Against the Contract, Note on Offloading*:
The Contractor is responsible for arranging the offloading of the assets on site at Environment Canada warehouse facilities.

Can we deliver the boat to Burlington using the trailer specified in Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.3 - *Trailer*?

A2: Yes, you may deliver the boat using the trailer specified in Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.3.

Q3: With respect to Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.2 – *Motor*:
Is a 2 strokes direct injection Evinrude motor acceptable for this solicitation? According to the manufacturer, the engine meets «EPA 2013 / CARB 3 STAR / EU » Emissions Compliance standards.

A3: Environment and Climate Change Canada is seeking outboard motors with equivalent emissions and fuel economy to Yamaha 4 stroke motors and will consider any motors that meet or exceed these standards.

Q4: With respect to Annex "A" - *Requirement*, Section 2.3 Mandatory Specifications, Sub-Section 2.3.3 – *Trailer*:
Does the trailer must be a single axle? As per Canada's TP 1332 and our experience with building vessels just like this one, a single axle will not be sufficient.

A4: A single axle has been requested for a number of reasons with one of the biggest issues being we cannot have brakes on the trailer.
