Request for Proposal Amendment no. 001 is raised for the following reasons: Questions and answers.

Question 1:

On the NPP it specifies four (4) 44 inch large format printers but doesn't mention double sided.

On the Request for Proposal section A3, page 23 it specifies 44" double sided large format printers but on page 28 section B3. it no longer specifies double sided printers. The requirements for the 60" printers specify double sided every time. Can you please clarify if the 44" printers are required to be double sided.

Answer 1:

Yes, the 44" printers are required to be double sided.
