2. Make changes to the RFSA/RFSO solicitation document.

a) Under Component I – Request for Bids Supply arrangement and/or Standing Offer

At Part 1 – General Information of the solicitation document

INSERT the following new Article 11:

11. Anticipated migration to an e-Procurement Solution (EPS)

Canada is currently developing an online EPS for faster and more convenient ordering of goods and services. In support of the anticipated transition to this system and how it may impact any resulting Supply Arrangement or Standing Offer that is issued under this solicitation, refer to the Article **Transition to an e-Procurement Solution (EPS)**, Article 17 of Component II – Part A - Supply Arrangement (SA) and Article 18 of Component III – Part A - Standing Offer (SO).

b) At COMPONENT II – Resulting Supply Arrangement, Bid Solicitation and Model - Resulting Contract Clauses - PART A - Supply Arrangement (SA) of the Solicitation Document

INSERT the following new Article 17:

17. Transition to an e-Procurement Solution (EPS)

During the period of the Supply Arrangement, Canada may transition to an EPS for more efficient processing and management of individual contracts for any or all of the SA's applicable goods and services. Canada reserves the right, at its sole discretion, to make the use of the new e-procurement solution mandatory.

Canada agrees to provide the Supplier with at least a three-month notice to allow for any measures necessary for the integration of the Supply Arrangement into the EPS. The notice will include a detailed information package indicating the requirements, as well as any applicable guidance and support.

If the Supplier chooses not to provide the supply arrangement of their goods or services through the e-procurement solution, the Supply Arrangement may be set aside by Canada.

c) At COMPONENT III – Resulting Standing Offer (SO), Call-Up Procedures for the SO and Call-Up Clauses issued against the SO at PART A – Standing Offer (SO) of the Solicitation Document

INSERT the following new Article 18:

18. Transition to an e-Procurement Solution (EPS)

During the period of the Standing Offer, Canada may transition to an EPS for more efficient processing and management of individual call-ups for any or all of the SO's applicable goods and services. Canada reserves the right, at its sole discretion, to make the use of the new e-procurement solution mandatory.

Canada agrees to provide the Offeror with at least a three-month notice to allow for any measures necessary for the integration of the Offer into the EPS. The notice will include a detailed information package indicating the requirements, as well as any applicable guidance and support.

If the Offeror chooses not to offer their goods or services through the e-procurement solution, the Standing Offer may be set aside by Canada.

All other Terms and conditions of the Request for Supply Arrangement/Request for Standing Offer remain unchanged.
