QUESTIONS AND ANSWERS

Question 19

In reference to Amendment 4 – question/answer 18, as well as Amendment 3 - question/answer 14, The Crown responded to the request to accept “older certifications along with more current training/courses?” with the opposite of the original request, by reducing the qualification to one option to meet the requirement from three options to meet the requirement (System Administration with SAP Netweaver, SAP Solution Manager or OS/DB Migration).

The Bidder respectfully requests that MT6 be amended, in the spirit of fairness, to the following:

Application/Software Architect (SAP BASIS) – Level 3

MT6 - The bidder must demonstrate that the proposed resource has obtained within the last 5 years from the original bid closing date a System Administration with SAP Netweaver certification, SAP Solution Manager or OS/DB Migration.

Note: a copy of the certification should be provided.
