**QUESTIONS AND ANSWERS:**

**Question 1:** Do you still require a separate 6" LCD monitor in order to have a borescope system equipped with 2 viewing screens? Or will the monitor integrated into the MViq handset suffice?

**Answer 1:** If the monitor is detachable, weight of the handheld controller of 2.3lbs or less is acceptable; with a monitor integrated to the controller a weight of 2.3lbs or less is acceptable.

**Question 2:** Will you accept the integrated Handset design of the Mentor Visual iQ?

**Answer 2:** Yes, if the weight is 2.3lbs or less.

**Question 3:** Will you accept our stereo forward tip that has a depth of field of 5mm to infinity?

**Answer 3:** Yes.

**Question 4:** Will you accept our two (2) side tips with depths of field of 1 to 30mm 6mm to infinity?

**Answer 4:** Yes.

**Question 5:** Will you accept the standard 3 meter length insertion tube?

**Answer 5:** No, we require minimum 3.5 meter.

**Specifications:**

1. Must be portable and work with battery power, as well as normal AC power.
2. Must have colour display and colour photo/video imaging capabilities
3. Must have a separate colour LCD monitor minimum 6 inch screen, or integrated screen is acceptable provided it weighs 2.8 lbs or less.
4. Must be able to take pictures and video that is transferable to a computer.
5. Must have an LED light source.
6. Must include a light weight hand controller (weighing less than 2.8 lbs.) with full 4 way (up, down, left, right) 360 degree power articulating scope tip.
7. Must include stereo or accurate comparative measuring software or capabilities with forward and side viewing tips (1 measuring and 1 normal) with close focus from 4mm side view and 5mm forward view
8. Must include optical tips to enable views from side depth of field 2mm to 15mm and forward view with depth of fields from 2mm to infinity.
9. Must include a flexible insertion tube minimum 3.5m, maximum 4.0m resistant to chemicals and moisture (insertion tube diameter minimum 3.0mm / maximum 4.4mm).
10. Must include a hard carrying and storage case which will not damage the borescope if the case is dropped from a height of 3 ft.
11. Must include an owner's manual in English, which provides step-by-step instructions for set-up and operation.
12. Must provide one training session in English for the complete operation of the borescope for 3 people. The training will take place in Regina. Training will take place within four (4) weeks after delivery of the unit on a mutually agreed upon date between the Technical Authority and the Contractor.
