AMENDMENT NO. 01

This amendment is raised to address bidder questions from the optional site visit and questions submitted via email:

A) Bidder Questions

Q1: "Is there any way to view the piles after the site visit?"

A1: Both sites can be accessible, however:

Marmot Pit is an active work site with Contractors and PCA maintenance crews that should be treated as such. PPE should be worn and caution taken. There are several other stacks of trees on the site as well that are not part of this contract so it is important that the bidder gets access to the provided photos so they can distinguish between them.

Kerkeslin Pit has a locked gate at the entrance but a quick walk past it up the entrance road and the bidder will be able to see the log decks. Again, there are some piles of old trees that are not part of this contract but it is easy to see which ones they are. There could also be PCA activity on the site.

- Q2: "The area around the log decks at Marmot does not leave much room for stock piling as there are other items and work going on in close proximity. What is the plan to allow for more room?"
- A2: PCA will clear an area close to existing pile for cut wood prior to mobilization
- Q3: "There are additional piles of logs in other locations in Marmot pit that are not shown in the pictures. Are these included in the contract to be processed?"
- A3: These are not included in the 595 estimated cords, in the current contract.
- Q4: "Would it be possible in the contract to increase the scope and add these logs or others into the contract?"
- A4: PCA advises to bid according to current scope of work and unit measurements.
- Q5: "Is it possible to bring in living quarters and stay on site for the duration of the project?"
- A5: Yes. For a fee of up to \$15.70 per day. Best management practices will apply and be given to the contractor prior to mobilization. Reminder that neither sites have electricity, potable water or waste water disposal.
- Q6: "Are there any services in Jasper that offer potable water delivery and waste water disposal services."
- A6: Yes.

ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT REMAIN THE SAME.
