SPECIFICATION

Section 01 10 10 General Instructions

1. Delete

1.1.10 – Decommission all electrical components down to the service disconnects in the basement of adjacent Cereal Header House Building 38 as per the Electrical Code of Canada. Removal and disposal to include all disconnects, panels, wiring, conduit and other electrical equipment.

And Replace with

1.1.10 - Decommission all electrical components back to the sub panels beside each greenhouse door from the Cereal Header House building 38 to greenhouse 38A and 38B, and back to the sub panel of building 29 for greenhouse 38C, as per the Electrical Code of Canada. Removal and disposal to include all disconnects, panels, wiring, conduit and other electrical equipment.

2. Delete

1.1.12 – In locations where the greenhouses are connected to the Cereal Header House and Building 29, make interior and exterior walls weather tight by sealing all penetrations, adding new bricks/blocks as necessary and repointing brick mortar joints that are cracked or damaged (existing and caused by the work). Match existing wall construction.

And Replace with

1.1.12 - In locations where the greenhouses are connected to the Cereal Header House and Building 29, make interior and exterior walls weather tight by sealing all penetrations, adding new bricks/blocks as necessary and repointing brick mortar joints that are cracked or damaged (existing and caused by the work). Match existing wall construction with like products as close to the original as possible.
