For INTERIOR wire harness connections please accept as an approved equal OEM Chassis and Bus Manufacturer standard connections that utilize compression, Weather Pack, Deutche or Amphenol style connections on interior of the bus and chassis as required. **APPROVED**

Weather Pack, Deutche or Amphenol style connections are environmentally sealed, designed for extreme temperature exposure and moisture exposure as well as exposure to harsh engine compartment fluids and chemicals.
