**Solicitation Amendment No. 002 is raised to answer questions from the industry.**

**Questions and Answers**

**Question # 1:** Does the Baby Warmer require to have MDL (Medical Device License)?

**Answer # 1:** No, the Baby Warmer does not require to have MDL (Medical Device License).

**Question # 2:** Is the Baby Warmer needed with all of standard features and the options **NOT** included neonatal resuscitation guidelines for labour and delivery?

**Answer # 2:** The requirement must be as noted in the Annex 'A' Requirement.

**Question # 3:** Can a listing of each facility and destination that could be delivered too provided, or an outline of the all 5 locations you are considering as part of this RFP?

**Answer # 3:** The 2 locations for the firm requirement are outlined in Annex 'A' Requirement. The location for units reflected in the option years are not yet known, however they will be classified as remote/isolated communities within the Ontario Region.

**Question # 4:** Can the closing date be extended for a week or couple of days to allow for appropriate bid preparation?

**Answer # 4:** Closing date cannot be extended at this time to meet the delivery date required.

**Question # 5:** What is the purpose for the bid for the mobile baby warmers?

**Answer # 5:** As stated in the Annex 'A' Requirement, the objective of this Contract is to purchase Basic Baby Warmers in order to ensure safe and effective care for new born who are delivered at nursing stations.

**Question # 6:** Were there any past fatal experiences in northern communities in Ontario to do with newborns and 'cold stress' or 'hypoxia'?

**Answer # 6:** The baby warmers are required to mitigate any risk, due to births in communities.

**Question # 7:** Do mobile baby warmers exist now? If so, where, how many exist, and how long in operation for?

**Answer # 7:** Currently there are no baby warmers in use in nursing stations.

**Question # 8:** Where these mobile baby warmers would be operated? In what setting? Please explain in detail.

**Answer # 8:** As stated in Annex 'A' Requirement, the baby warmers are required to be located in two nursing stations, located in Sandy Lake and Pikangikum. The stations provide urgent, emergent and primary care services,

provided by registered nurses with the support of physician. Patients who require admission and further treatment are transferred to provincially funded hospitals in urban centers.

**Question # 9:** According to the bid, one unit of mobile baby warmers will be delivered to Sandy Lake and Pikangikum. When will this take place, approximately?

**Answer # 9:** The delivery date of the units will be determined with the successful bidder once the contract is awarded, however must be completed by January 31, 2019, as stated in the RFP.

**Question # 10:** Is there a sketch or drawing of a mobile baby warmer and what it might look like?

**Answer # 10:** This is not available.
