QUESTION AND ANSWER

Question 23

Please refer to the revised rated criteria RT6 for the resource category of Application/Software Architect (SAP BASIS) – Level 3 which states “The bidder should demonstrate that the proposed resource has obtained within the last 10 years from the original bid closing date a SAP HANA certification and/or a SAP Solution Manager or OS/DB Migration certification.” Since the main priority of the statement of work involves a migration to a HANA database, would the client accept 2 HANA certifications in lieu of a Solution Manager or OS/DB Migration certification? Examples include any two of the following: “Certified Technology Associate – System Administration (SAP HANA as the database) with SAP Netweaver 7.4” or “Certified Technology Specialist – SAP HANA Installation”; “Certified Technology Associate (Edition 2015) - SAP HANA”, “Certified Technology Associate - SAP HANA 2.0”
