

AMENDMENT 004

The purpose of this amendment is to answer questions from industry.

Question 1

How many lock down buttons need to be installed?

Answer 1

There is one (1) installed but not connected. In total there are 3 more buttons to be installed and all 4 buttons must be connected. These should also be within a protective cover in order to prevent inadvertent depression of the button.

Question 2

What is the distance between the lock down buttons and the control panels?

Answer 2

The maximum distance between the lock down buttons to the nearest control panel would not exceed 40m.

Question 3

What is the distance between the control panel and perimeter doors?

Answer 3

The maximum distance between the perimeter doors to the nearest control panel would not exceed 40m.

Question 4

Please advise as to the length of conduit required between perimeter doors, lockdown buttons and control panels?

Answer 4

The maximum distance between the lockdown buttons or perimeter doors to the nearest control panel would not exceed 40m.

Question 5

Is the table at page 24 in the RFP accurate? Please confirm quantities at various locations.

Is there 4 exterior doors in the Jean-Talon West side?


