Addendum no. 2

1. **EXTENSION OF TIME**

Notice is hereby given that the time for the reception of tenders previously due November 22, 2018 is hereby extended to **14:00 hours, November 27, 2016**.

2. **INVITATION TO TENDER**

**REMOVE** "Appendix 1 – Combined Price Form" and **REPLACE WITH** the "Appendix 1 – Combined Price Form revised November 19, 2018".

Note: The Appendix 1 – Combined Price Form revised November 19, 2018 attached in this amendment is the Combined Price Form that **MUST** be submitted with your bid. Failure to comply with this requirement will result in your bid being deemed **non-responsive**.

3. **QUESTIONS AND ANSWERS**

Q1: The drawings note (sheet 2) that the anchor bolts and prefabricated anchor inserts to be disposed and replaced by new ones to match existing. Can you provide the length and nominal size?

A1: The existing guiderail post anchors are 25.4mm diameter and have an embedment of 200mm with a 100mm hook.

Q2: In drawing sheet no 5, it is mentioned that deteriorated reinforced steel to be removed and new ones to be installed in the existing deck by approved embedment methodology. Can you provide the approved method?

A2: Reinforcing steel in pristine condition may be left in place for reuse in new work. Careful removal of existing concrete is required to minimize any damage to components that will be reinstated in the new work. Where existing deteriorated reinforcing steel is found during concrete removals, or where reinforcing interferes with relocation of tie-rod bolts, Contractor is to propose an embedment methodology for installation of new reinforcing rebar to reinforce the concrete to full capacity of original steel (methodology to be approved by the Departmental Representative).

Q3: For the electrical services inside the concrete guard and inside electrical conduits, who is responsible for the disconnection and pulling of the cables, and if this is within the scope for how long can the facility provide a shut-down period?

A3: The electrical contractor is responsible for pulling of the cables. The work must be coordinated with the Departmental Representative (and the Owner's electrician) for disconnection and de-energizing of the wires. The terminal is fully active and will remain operational throughout the project.
