- Q1. Some of the conditions listed in the (RFSO EQ754-191576/A) document would require changes and consultant's legal department acceptance prior entering into further agreements for each individual assignment. Will this be possible to submit the bid under the assumption that mutually accepted legal terms and conditions would be revisited and revised as required at a later date during actual scope of work review period?
