1. QUESTIONS AND ANSWERS

Question 1:

Q1: What does CRA mean by protected CRA information? Also, below, under the Physical Security Requirements and the in transit section, what does OC stand for?

A1: Protected information– information related to other than the national interest that may qualify for an exemption or exclusion under the Access to Information Act or Privacy Act, and the compromise of which would reasonably be expected to cause injury to an individual or an organization. The three levels of Protected information are: A, B and C. OC stands for Outside Consultant(s).

Question 2:

Q2: Page 10 of the solicitation, 3.1 Bid – Number of Copies section. CRA mentions providing one hard copy of the bid in separately bound sections. Does bound mean each section should be in a binder or is providing cerlox bound copies of each section acceptable? We are also to provide 1 soft copy of each section on USB. It looks like each section should be on a separate USB, correct?

A2: Each of the four sections have to be submitted separately to facilitate their review by different evaluators. Cerlox bound copies of each section is acceptable.
Each of the four section detailed in Part 3 – Proposal Preparation Instructions- should be submitted on a separate USB.
