INVITATION TO TENDER
RESTAURATION OF PILLAR – ÎLE DU MOINE (FP)**

The purpose of Amendment 004 is to answer questions, add a sketch with pictures for access to the site and to modify the BID AND ACCEPTANCE FORM (BA).

Please apply the following changes to the Invitation to tender (ITT):

- 1) Questions and answers 1 to 10
- 2) Sketch with pictures for access to the site
- 3) Modify the BID AND ACCEPTANCE FORM (BA).

1) QUESTIONS AND ANSWERS

QUESTION 1

At detail 04E of plan S04, 800 mm of existing soil is to be excavated around the concrete structure. Should the embankment be done with the same material?

ANSWER 1

Backfilling can be done with the material that will be excavated.

QUESTION 2

What is the operation to access the site?

ANSWER 2

The site of Île du Moine FP is located in the municipality of Sainte-Anne-de-Sorel and can only be reached by boat or an ice bridge depending on the season. The site is also accessible by helicopter.

The coordinates are as follows:

Latitude: 46 ° 04'00.35" North

Longitude: 73 ° 01' 07.14 "East

The navigation light is on the west side of the island of Moine in front of the Sainte-Anne-de-Sorel Marina. The Contractor shall obtain and pay for the necessary authorizations and permits for the use of private access roads and private lands adjacent to the Work, maintain and remove snow if necessary during the Work and repair any damage resulting from the work.

Throughout the duration of the work, the Contractor must:

- Use existing access roads, develop and maintain suitable tracks to allow access to the work site according to the Department's rights of way or prior agreement with the owner;
- Once the work has been completed, clean the tracks, taxiways and terrain that have been used by the Contractor and restore them to their original condition to the satisfaction of the Ministerial Representative;
- Do not unduly accumulate materials, equipment or residues on the premises. Daily cleaning of the premises is required.

QUESTION 3

Should we protect the site with fences around?

ANSWER 3

It will not be necessary

QUESTION 4

In section 1.2.1.4 of the specifications section 01 45 00 QUALITY CONTROL, it is stipulated to reserve a part on site for the laboratory staff.

ANSWER 4

Adequate space to allow the concrete specimens to be cured on site to be protected from the sun, wind and other sources of rapid evaporation and to have the conditions of cures in accordance with the demands of the laboratory that will do the tests

QUESTION 5

Please specify and provide details of the connection of new columns to existing beams (welding, bolts, etc.).

ANSWER 5

The connections will be chosen by the Contractor. He must submit the signed and sealed plans by a competent engineer member of the OIQ.

QUESTION 6

Please specify the dimensions of the new HSS columns.

ANSWER 6

HSS 152 X 152 X 6,4

QUESTION 7

The detail 03C of the S03 plan seems to show a complete repair of the underside of the structural slab. A note to detail 06A of plan S06 states that the entire interior area of the slab is to be repaired. The sketch of detail 06A of plan S06 seems to show local repairs.

- Please specify whether local repairs or a complete repair of the underside of the slab?
- Also specify if a shotcrete can be used instead of the requested repair mortar (the repair mortar is probably better suited for local repairs)?

ANSWER 7

Local repairs are required on the top of the slab (exterior) - detail 04A = 12m². Repair under the slab (interior side) - detail 06A - On the entire surface of the interior slab.

QUESTION 8

The 03C cut of the S03 drawing seems to show a complete repair of the underside of the structural slab. A note to detail 06A of plan S06 states that the entire interior area of the slab is to be repaired. The sketch of detail 06A of plan S06 seems to show local repairs.

- If complete repair under the slab is required, how should the integrity of the concrete structure be ensured while the central support beam will be completely clear (see Plan S03).

ANSWER 8

The Contractor shall support the slab as required and submit a sealed and signed plan by an engineer (see demolition quote section).

QUESTION 9

Does the Government of Canada provide transportation to the Island?

ANSWER 9

No, the Contractor will be solely responsible for organizing and providing all transportation of equipment and personnel for the execution of the work. It will also provide transportation for Departmental Representative and laboratory staff visits for quality control.

QUESTION 10

Please confirm the date of the notice of acceptance of the offer as quoted in section SA06 DURATION OF WORK. Is it immediately after the closing of the tender or in winter 2018-2019 or spring / summer 2019?

ANSWER 10

Yes, notice of acceptance of the offer will be given as soon as possible after closing for Work during the winter period 2018-2019.
