5. Questions and Answers From the Suppliers Conference

Q1. Annex A - Purchase Description - 3.4 Performance Item (b) and (c) rated horsepower. Is rated horsepower gross engine horsepower, net engine horsepower or rated PTO horsepower?

A1. Engine net rated power must be used and proof of compliance documented with proposal. The Purchase Description was modified with this clarification.

Q2. Document Annex A - Purchase Description - 3.5.2 Attachments, Accessories and Features: (a) Loader – Could you give a full description of loader requirements (non-self-levelling or self-levelling, manual or hydraulic implement coupler, ride control, 3rd or 4th hydraulic function requirements, etc.)?

A2. The minimum loader requirements are described in the Purchase Description under 3.5.2 (a). This means that a non-self-levelling system with pin-on bucket will meet the requirements. Items such as additional hydraulics are only necessary if required to operate attachments that are requested in a specific Request For Proposal.

Q3. Document Annex A - Purchase Description - 3.5.2 Attachments, Accessories and Features: (g) Front Mounted Snowblower, (j) Angle Dozer Blade and (m) Front-Mounted Sweeper - Is there a requirement for front mounted 3 point hitch and front mounted PTO with front mounted attachments?

A3. There is no stated mandatory requirement for front mounted three point hitch and front PTO. There is a requirement to power the attachments and to provide a lifting mechanism for these three attachments. The method through which this requirement is met is not directed. If a front mounted PTO or front mounted three point hitch is necessary to run the attachments ordered on a specific Request for Proposal, then they must be provided.

Q4. Annex A - Purchase Description - 3.6.1 Operator Station Equipment (a) Suspension Seat – Do you want standard mechanical suspension seat or optional air suspension seat where available?

A4. Any seat that qualifies as a suspension seat and meets all other requirements of the Purchase Description is acceptable.

Q5. Document Annex A - Purchase Description - 3.11 Tires – The vehicle tires must have R-4 Industrial Treads. 3.11.1 Tire Accessories (b) Turf Tread in lieu of R4 tires: Are either Nokian TRI 2 or Alliance Multiuse 550 tires acceptable substitute for R4 industrial tires or turf tires?

A5. Both the Nokian TRI2 and Alliance Multiuse 550 tires could qualify as turf tires and are acceptable R-4 Equivalent tires. The Purchase Description was modified to include that tires Equivalent to R-4 Industrial can be proposed.

Q6. Document Annex B - Technical Information Questionnaire Agricultural Tractors. For configurations A thru H do we list all models that fall in that horsepower specified?

A6. It is possible to qualify more than one model for any Configuration. However, as the Contract will always be awarded to the lowest cost compliant proposal, there are limited advantages in qualifying multiple machines under the same Configuration.

Q7. We are interested in the end use of the Agricultural Tractors that are in the tender. The scope is general and broad, but understanding what end use the tractors can be used for will assist in configuration.

A7. The Supply Arrangements will be open to a multitude of Government Entities with varying roles. It is therefore not possible, nor would it be helpful, to list all possible end uses.

Q8. Reviewing configuration D, E, F there is an option for Front-Mounted Snow Blower and Front-Mounted Sweepers. While these options are available, the rear-mounted options for these attachments are vastly more cost-effective.

A8. This is noted. As the Supply Arrangements are built to suit many different Government Entities requirements, these options must remain available if requested for particular applications.

Q9. Configurations D and E would struggle using some of the larger Disk Harrow (20-24 feet wide). These are not recommended.

A9. The Appendix 1 - Purchase Description Agricultural Tractors has been revised and the Requirements for Disk Harrow on Configurations D, E and F have been modified.

Q10. Configuration A and B would struggle using some of the large Heavy Duty Rotary Cutters. These are not recommended.

A10. The Appendix 1 - Purchase Description Agricultural Tractors has been revised and the Requirements for Heavy Duty Rotary Cutters on Configurations A and B have been modified.

All other terms and conditions remain unchanged.
