Q4 With regard to ATTACHMENT 1 TO PART 4 - FINANCIAL PRESENTATION SHEET.
Many items requested in this contract are not from the commercial furniture world. When the pricing is supplied to us from the various vendors, it is typically a NET price. There is not typically a MSRP price and therefore we cannot apply a MSRP List or MSPR discount.

Q6. As per RFSO Attachment 2 to Part – 4 Offered Products List , item 17, Table 1b is requesting a sliding door fridge, but the listed model is one for a swing door fridge. Please clarify whether the requirement is a swing door or sliding door model.

Q7. When offering equivalents prior to the solicitation closing date, should Offerors submit separately or can they be grouped together on one sheet?

A7. As outlined in Amendment #2, Questions and Answers – Series I, A2, Offeror's are to complete the Details column in Attachment 2 to Part 4 (Equivalent Product Offered).

When an equivalent product is offered, Offerors must provide additional information (to Manufacturer, Model Number/Series/Dimensions and Finish/Colour) that demonstrate how Offered Product meets the Product Requirements List Specification, as per Attachment 1 to Annex A – Product Requirements List.

Offeror may submit requests for equivalent products separately or altogether, prior to solicitation closing date.

Q8. Would PSPC extend the solicitation closing date?

Q9. As per RFSO Attachment 2 to Part – 4 Offered Products List, item 18, CLOC- 04, the listed product example is only offered in minimum quantity of 100. Please confirm if that is the requirement.

A9. For the purposes of evaluation and in any resulting Standing Offer Basis of Payment, the rate/price for the Offered Product will be a quantity of 1. The quantity of 1 refers to 1 unit or the minimum quantity specified in the item's mandatory specifications. Certain items in list may have a minimum quantity. Please refer to amendment below for items with a minimum quantity requirement.

Q10. Are you able to provide quantities and volume estimates for each package?

A10. Please refer to amendment below for items with a minimum quantity requirement. PSPC does not have an estimated quantity or business volume for any of the items listed in the Product Requirements List. However, please refer to Part 1 – General Information, 1.2.13, for the

estimated annual business volume for the resulting Standing Offers resulting from Miscellaneous Furniture and Equipment RFSO #EP803-183135/E and #EP803-183135/I.

Q11.1. In regards to item OHSE-02 Automated External Defibrillator, would it be of preference that the unit be able to be switched between English and French? Canadian languages by the press of button at anytime without interrupting the rescue prompts?

Q11.2. Would a non-color back lit text display showing time of rescue, shocks delivered, and bilingual text prompts be of preference?

Q11.3. The latest devices are capable of Visual and/or Audio real-time feedback and/or coaching with impedance and accelerometer (rate & depth) to 2015 AHA/ERC acceptable parameters for CPR. Since the 2015 Heart and Stroke Resuscitation Guidelines recommend the use of CPR feedback.
