Amendment number 001 is raised to answer supplier questions:

Q1: Regarding subject RFSO for DND bulk aviation fuel requirements – BC251, can you please confirm the standing offer period? The RFSO states that the period of SO is from date of issuance of standing offer, up to an including March 31, 2019. The RFSO closes Jan 9, 2019.....does this mean the SO period will only be for approx. 2 months? 500 KL to be delivered in a 2 month period?

A1: It is anticipated the tanks will be ready to take fuel in February 2019. The requirement will be February 2019 to the end of the current Standing Offer period, March 31, 2019, approximately two months. The original estimate was based on six months, over two months the estimated delivery volume is closer to 160,000 L.

Q2: Is F-34 a must? Jet A1 with FSII is not an adequate substitute?

A2: The RFSO states the requirement is for F34. As per the RFSO Part 3 Section I Technical offer - B, Jet A-1 with FSII and CI will be equally accepted. As per the RFSO Part 3 Section I Technical offer – C, Jet A-1 with FSII will be accepted if no offer is received for the requested product or its equally accepted alternate.

Q3: I see the term of the contract being from January 2019 through March 2019. 3 months. Is this correct?

A3: This is a new requirement which is being added to a Standing Offer in place already which expires March 31, 2019. This requirement under this standing offer will be until March 31, 2019.

All other terms and conditions of the Request for Standing Offer remain unchanged.
