## Answer 3:

- a. 5.3 An Integrity declaration form must be submitted **only** when:
  - the supplier, one of its affiliates or a proposed first-tier i) subcontractor has, in the past three years, been charged with or convicted of a criminal offence in a country other than Canada that, to the best of the supplier's knowledge and belief, may be similar to one of the listed offences in the Ineligibility and Suspension Policy (the "policy"); and/or
  - ii) the supplier is unable to provide any of the certifications required by the Integrity provisions.
- b. 5.5 Bidders have the option of completing the List of names for integrity verification form online or using a PDF version at the link below:

c. 5.8 and 5.9 – No further information is required for Additional Certifications Precedent to Contract Award 5.8 or 5.9. Part 2 – Bidder Instructions of the RFP specifies that, "Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract." Therefore, Bidders are effectively certifying Status and Availability of Resources and Education and Experience when they submit a bid.
