INSTRUCTION FOR NOCFC SAMPLE VIEWING

Refs: A. Request for Proposal, Section 2.6

1. The Sample Viewing for NOCFC items will take place from Dec 3-7 2018 and from Dec 10-14 2018 from 0900 – 1530 at the National Printing Bureau (NPB), 45 Boulevard Sacré-Coeur, Gatineau, QC J8X 1C6, in room B-3004-2.
2. The NOCFC Sample Viewing will provide Bidders and Suppliers an opportunity to view and examine all NOCFC items in order to:
 - a. provide an accurate pricing at bid; and
 - b. examine the expected quality of all NOCFC items.
3. For security reasons, participants must provide the names of all persons planning to attend the viewing and the expected dates. Participants must present themselves at the commissionaires' desk at the NPB west entrance at 9h00. The commissionaires will call a DND representative to escort the visiting persons to the viewing room. If you are not able to come at 9h00, contact DND to arrange an appointment. The contact persons are listed at the end of this message.
4. Participants may bring in note-taking material, personal computers, and cameras.
5. Two private viewing rooms are provided. These rooms can be used for internal group discussions and will operate on a "first come, first serve" basis.
6. A DND Representative will be present at all times to answer any questions while Industry Representatives are handling and viewing NOCFC items.
7. Bidders/suppliers are reminded that only information that is published within the RFP document or an Amendment to the RFP issued by Canada is binding on Canada. Bidders/suppliers are therefore encouraged to submit written questions to the Contracting Authority identified in the RFP to confirm the specifications and requirements or seek clarification.
8. All NOCFC items must remain in the viewing room at all times. Participants must return the items in their designated areas or return them to a DND representative.
9. NOCFC items are organized logically by material type and Canadian Content Grouping. DND will provide Industry Participants a full list of NOCFC items with corresponding NATO Stock Number (NSN) and location mapped within the Viewing Room. You can find any item by referencing its (NSN) and designated display area.

10. All NSNs on the Line Item Unit Cost list (LIUC) are represented by a sample. Refer to the Sealed Sample Tags and the full list of NOCFC items for special considerations and additional information.
11. Textiles referenced within the Technical Data Packages are laid out on Table 7.
12. DND reserves the right to ask any participant to leave at any time if they deem necessary.
13. After the viewing period ends on December 14, 2018, viewing samples will be made available to bidders throughout the remainder of the solicitation period by appointment only. Bidders are to contact the Contracting Authority to request an appointment date and time.
