TITLE : Breakwater extension, Rimouski est, Bas St-Laurent

QUESTION AND ANSWER:

Question 10 : In response to question # 9, it is noted that the selected quarry must be derived from a geological formation consisting of a minimum of 90% quartz. The geological maps as well as the descriptions of the different geological formations of Quebec do not have all the quartz and / or SiO₂ contents. In addition, a stone can be composed of 90% quartz grains in a calcareous matrix. The resistance of this type of rock may be less important than a stone that is composed of 90% quartz grains in a siliceous matrix. To determine the quartz content of a stone, it is essential to have a thin, polished blade. In the current period, it is impossible to perform a petrographic examination. How should we proceed?

Answer 10 : Please refer to question #9. We believe that the information contained in scientific reports (available on the internet) concerning the various geological formations composing Quebec quarries are sufficient to evaluate the average percentage of quartz and establish a bid respecting plans and specifications. However, the tests with thin polished blades will be required by DFO to demonstrate the percentage of quartz before beginning of stone production. As for the other criteria for rock quality, please refer to the specifications section 35 31 24. A calcareous rock may not respect, amongst others, the water absorption criterion or the wear resistance. These standard tests are usually already available for all quarries.

Question 11 : In the event that the density of the stone exceeds the upper limit of 2.85 established in Section 35 31 24, is the payment of these stones maximized at that limit or does Canada make the payment according to the actual density of the stone used?

Answer 11 : Stone will be paid by the metric ton whatever the stone density.
