### **SPECIFICATIONS:**

#### **1.1 REVISIONS**

1.1.1 In section 02 83 10 Lead - Based Paint Abatement – Minimum Precautions specifications change  
1.1.01.4 *“Removal of grey trim including wainscoting inside the Old Lighthouse/Dwelling coated with lead-based paint with non-powered hand tool such as a pry bar, other than manual scraping and sanding and replace to match existing. Refer to Photo 4 in Appendix B”* to *“Removal of grey door and trim and wainscoting inside the Old Lighthouse/Dwelling coated with lead-based paint with non-powered hand tool such as a pry bar, other than manual scraping and sanding. Refer to Photo 4 in Appendix B”*.

#### **1.2 CLARIFICATIONS**

1.2.1 Lead based paint materials identified in section 02 83 10 Lead - Based Paint Abatement – Minimum Precautions; to be removed with chemical gel or paste with the substrate remaining in place or the substrate material can be removed with the use of non-powered tools as a pry bar, other than manual scraping and sanding with replacement of the substrate (i.e. door, trim, wainscoting).

#### **1.3 ADDITIONS**

1.3.1 Add to section 02 83 10 Lead - Based Paint Abatement – Minimum Precautions, the removal of the wood stairs and railing coated with red lead-based paint with the use of non-powered hand tool such as a pry bar, other than manual scraping and sanding. Stairs and railing are to be replaced to match existing. Alternatively, the stairs and railing may remain in place and the red paint can be removed with the use of chemical gel or paste and fibrous laminated cloth wrap. This work will be paid as part of the lump sum amount.

1.3.2 Add to section 02 83 10 Lead - Based Paint Abatement – Minimum Precautions, the removal of the 3 layers (yellow/red/grey) of lead based paint on the concrete floor in the basement of the Lighthouse Keeper’s Dwelling with the use of non-powered hand tool such as a pry bar, other than manual scraping and sanding and the use of chemical gel or paste and fibrous laminated cloth wrap. Repaint the basement floor to match existing. This work will be paid as part of the lump sum amount.
