Amendment 001 is raised for the following:

Question 1: Must proposals include bids for all 3 items listed in the tender or can a bidder submit a proposal on 1 or 2 of the 3 items?

Answer 1: Bidders may submit proposals on 1, 2 or all 3 of the items listed in the tender.

Question 2: For the self-propelled treadmill, would you accept console readings to be: distance (km), time, speed (km/hr) and calories only?

Answer 2: No. The treadmill must have the ability to display a minimum of Distance, Time, Calories, Watts and Heart Rate.

Question 3: Are installation services required as a part of this tender?

Answer 3: If the items are shipped unassembled, then installation must be included. If the items are shipped assembled, there is no requirement for installation as they will simply be wheeled into place.
