## **QUESTIONS AND ANSWERS**

### **Question 1:**

Amendment 4 indicates a new due date of January 10, 2019, despite all due dates previously indicating January 18, 2019. Regardless, there has been a delay in response time for questions that has had an impact on our response. Would PSPC please consider extending the due date to 18 February 2019?

### **Response 1:**

PWGSC released the Linguistic Services Request Management System (LSRMS) Request for Proposal (RFP) in three consecutive releases, but with one bid solicitation closing date. The RFP Release 3 containing the bid preparation instructions and evaluation plan was released on November 30, 2018. The solicitation closing date provides bidders forty days to submit bids. The solicitation closing date will remain unchanged.

### **Question 2:**

Thank you for publishing the answers to the questions I sent on October 2<sup>nd</sup>. Considering the number of additional questions and answers, I note that you have changed the date of delivery of the RFP to January 10, 2019. Considering all the changes, it seems appropriate to me to request an extension of the closure date of the RFP to 21 February 2019.
