1) QUESTIONS AND ANSWERS

Q1) Annex "A" 2.5.I and Annex "C" M5: The door.... feature a window that is a minimum 18" wide and 60" high to a maximum 20" wide to 62" high.

Our door includes a window that is 22" wide and 66" high for higher visibility and safety. Can you please confirm acceptance of our window dimensions.

A1) Yes that is acceptable.

2) SOLICITATION DOCUMENT AMENDMENT

1. At Annex "A" Requirement – 2.5 Cubicle Features

DELETE: I. The door on the cubicle must be a 3'wide, sound isolating door (that follows the above referenced NIC), and feature a window that is a minimum of 18" wide and 60 " high, to a maximum of 20" wide to 62" high.

INSERT: I. The door on the cubicle must be a 3'wide, sound isolating door (that follows the above referenced NIC), and feature a window that is a minimum of 18" wide and 60 " high, to a maximum of 22" wide to 66" high.

2. At Annex "C" Mandatory Technical Criteria – Mandatory Criteria M5, Requirement

DELETE: The door on the cubicle must be a 3'wide, sound isolating door, and feature a window that is a minimum of 18" wide and 60"high, to a maximum of 20" wide to 62" high.

The cubicles must include a lock and key system.

INSERT: The door on the cubicle must be a 3'wide, sound isolating door, and feature a window that is a minimum of 18" wide and 60"high, to a maximum of 22" wide to 66" high.

The cubicles must include a lock and key system.
