Solicitation Amendment No. 002

Title: Portable Restroom Trailer

(1) This solicitation is hereby amended to provide the following questions and answers:

Question #2:

Q2: You have indicated a 100 gallon fresh water tank and a 370 gallon waste tank; these proportions do not make sense with low flush toilets; I would recommend 140-150 fresh with 200-250 waste.

A2: The requirements state a MINIMUM 100 gallon fresh water tank and a MINIMUM 370 gallon waste tank due to operational requirements. Larger waste tank capacity is needed to reduce the frequency of service.

Question #3:

Q3: Trailers are not built to building codes; we have everything CSA approved, would this be acceptable?

A3: All materials and equipment forming part of the restroom trailers must be CSA approved and installed according to such standards, as applicable. Trailers must also meet road safety standards in Canada.
